- 1 The Royal Government of Cambodia (RGC) has received a Credit from the World Bank (WB) toward the cost of the Road Connectivity Improvement Project (RCIP), and it intends to apply part of the proceeds of this credit to payment under the Contract for the Supply and Delivery of Three [3] Pick-up (Lot1) and One [1] Van (Lot2).
- 2 The Ministry of Public Works and Transport now invites sealed bids from eligible and qualified bidders for the Supply and Delivery of Three [3] Pick-up (Lot1) and One [1] Van (Lot2).
- 3 Procurement will be conducted through National Competitive Bidding Procedures outlined in the Procurement Manual for Externally Financed Projects/Programs, and under the laws and regulations governing public procurement within the Kingdom of Cambodia.
- 4 This invitation is opened to all eligible bidders from eligible source countries as described in the Bidding Document.
- 5 Qualification requirements as specified in ITB Clause 14.2, Documents "Establishing the Eligibility and Qualifications of the Bidder", and in the Bid Data Sheet.
