 - Evidence of performance for Construction Completion (5 year terms: 2017.09.01~2022.08.30)
- Only eligible Bidders with the following key qualification may be able to participate in this Bidding:
 - The above (Ⓢ) documents are to be required for Pass or Fail judgment.
 - RFP (request for proposal) will be informed and distributed to any Bidders which will have passed the mentioned key qualification as scheduled.
- Joint Venture or Consortium: Not Applicable.**

- This Invitation for Bids (ITB) follows the General Procurement Notice for this Project that appeared in [Cambodia Newspaper], published on **Aug 01, 2022**.
- The KOICA (Korea International Cooperation Agency) Cambodia Office (“the Employer”) invites sealed Bids from Bidders for the construction (remodeling) and completion of Project for ICT Capacity Building of Lower Secondary Education in Cambodia. International Competitive Bidding will be conducted in accordance with the KOICA’s Rules and Procedures for Procurement of Works
- Registration of participation in Bidding by “Letter of Interest” with the relevant attachment in person to KOICA Office (Original) as well as through email (Softcopy) in using the given format as designated hereto, from **Aug 08 to 17:00, Aug 12, 2022**
- Applicants who are notified to participate in the bidding may receive the bidding documents directly from the KOICA office in the Cambodia by **17:00 (Cambodia Time) on August 19, 2022** or receive the bidding documents by E-mail.
- Pre-bidding meetings shall be replaced by the distribution of tender documents.
- A complete set of Bidding Documents will be distributed in the form of electronic documents at free of charge.
- The provisions in the Instructions to Bidders and in the General Conditions are those of the KOICA’s Standard Bidding Document for Procurement of Works.
- Bids must be delivered to the address below on or before **17:00 (Cambodia time) on September 15, 2022** and must be accompanied by a Bid Security of equivalent to two point five (2.5) percent of the bid price. Electronic bidding will not be permitted. Late bid will be rejected.

- The site separately visits by each company (KOICA Cambodia office will announce the future period).

- All bids must be accompanied by a Bid Security equivalent to two point five percent (2.5%) of the **Bid Price** with its guarantee period from no later than Bid Closing Date up to not less than Thirty Days (30 Days).

- KOICA Office shall not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of bids
