1. The Kingdom of Cambodia has received financing from the Asian Development Bank (ADB) towards the cost of **Road Network Improvement Project (Phase 2)**. A portion of this financing will be applied for eligible payments under the contract named above. Bidding is open to Bidder from eligible source countries of the ADB.
2. The Ministry of Public Works and Transport (the "Purchaser") invites sealed bids from eligible Bidders for the Supply and Delivery of 2 Vans and 2 Portable Weigh Scales ("the Goods").
3. Open Competitive Bidding (National Advertisement) will be conducted in accordance with ADB's Single-Stage: One-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. Only eligible Bidders with the following key qualification should participate in this bidding:
 - A manufacturer's authorization form is required;
 - The Bidder has satisfactorily completed at least two (2) contracts for supply of similar goods in the preceding three years of not less than 50 percent of the bid price in each contract;
 - The Bidder has completed contracts in the total cumulative amount equal to at least US\$560,000 in the preceding two (2) years;
 - Access to a line of credit or cash in bank account of an amount at least US\$140,000, net of other contractual commitments; OR
 - Credit terms with vendors specifically for the goods to be supplied under the contract, of an amount at least US\$140,000 and valid for at least 6 months after the deadline date for submission of bids specified in ITB clause 21.

The qualification criteria are more completely described in the Bidding Document.

The Government and/or the ADB will respectively declare a Bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by them, if it at any time they determine that the Bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in competing for or in executing a contract.
